WFMA Vision, Mission, and Aims, and Objectives for 2023-2024

Background.

WFMA Support Centre. Objectives for the drop-in Centre for 2022-23 have been met. During 2022 the population of asylum seekers in Waltham Forest grew substantially, including 400 people (1/3 minors) housed in hotels, and others referred from boroughs around England. WFMA can only offer immigration advice and casework to migrants and persons already granted refugee status, but not to individuals who want to apply for asylum, or who have already applied for asylum and are awaiting a decision. (However legal aid is available to asylum seekers to obtain legal representation, so we use our limited resource for those without this type of assistance). WFMA does offer other types of support to asylum seekers, as well as to migrants and refugees, such as referral to food banks and other sources of practical help, and this work has greatly increased since mid- 2022. Consequently there is a need to expand the volunteer base for the weekly drop-in Centre. WFMA also aims to register with the OISC and train up committed volunteers with Refugee Action, so as to be able to offer advice to Level 1.

The Centre has benefitted enormously from the appointment of a part-time manager, with funding from Trust for London. With the Trust's assistance, she has drawn up a Monitoring and Evaluation plan for our advice work.

Campaigning remains an important focus. In 22/23 WFMA developed leaflets and continues to signpost and to support local and national campaigns.

Other ambitions set out in our objectives for 2022-23 have had to be deferred due to capacity issues. Funding for a part-time volunteer coordinator/administrator post, as well as for unrestricted funds, are a priority for grant applications. With such a post, volunteer roles could be expanded in particular to organize campaigns, events, PR and social media activities.
